## **College Station Animal Control Multi Pet Permit Guidelines**

Thank you for following the ordinances of College Station by requesting a multi pet permit. The following criteria will be considered when processing multi pet permit applications.

1. Whether there is compliance with applicable laws, rules and regulations.
2. Whether all your dogs and cats that are at least 4 months of age are current in their vaccination and license, whether tags are attached to a collar and whether the animals are optionally microchipped.
3. Animals must have sanitary shelter, food, and water. Outside shelter must be adequate to protect the animals from elements they could not otherwise withstand without such shelter in place. Food is recommended to be kept in a plastic container with a lid or otherwise be kept in a clean, durable and secure manner. Water should be clean and appropriately available such as in a spill-proof bowl.
4. Animal waste should be properly discarded so as not to become a problem, such as placement in plastic bags and disposed of in the city trash on a weekly basis.
5. Generally speaking, approximately 40 cubic feet of living area and 32 square feet of floor space is needed per cat and dog, respectively.
6. If you are breeding your animals, it will be verified that city land use regulations allow this use and that you have met any additional requirements that may apply.
7. Any complaints regarding your animals will be investigated. Alleged violations include but are not limited to those found in the College Station Animal Control Ordinance, Texas Health and Safety Code and the Texas Administrative Code. The City Code of Ordinances can be viewed online from a link at [www.cstx.gov](http://www.cstx.gov).
8. Upon receipt of a complaint to the City or at any time the City reasonably believes there may be noncompliance, you understand that you and all parties of the residence to which the permit relates may be part of an investigation conducted by the City.
9. In accordance with the city ordinance, all pets must be kept on the owner's property or physically restrained (on a leash) at all times when off your property.
10. The permit is valid for one year from the date of issuance. It is the owner's responsibility to complete a permit renewal before the permit expires.
11. The permit may be revoked as set forth in the ordinance, including because an application is incomplete, false or inaccurate; you receive a charge relating to the care and humane treatment of animals; or there exists circumstances indicating it is in the best interests of the health and safety of the public that such permit be revoked.
12. The owner is required to notify Animal Control in a timely manner of any changes in the application, such as a change in the number of animals, address, etc.
